SMGT 447A, 90 hours of accumulated course credit, 2.00 GPA overall, and advisor's consent.

#### **Course Description**

SMGT 447B. Internship in Sport Management (1 – 12). Second internship experience for students in sport management; takes place in a different setting than SMGT 447A. Students spend the equivalent of full-time employment in an appropriate agency for a total of at least 640 hours.

#### **Definition of a Credit Hour**

University policy mandates an expectation that students will spend, for each credit hour, a minimum of 45 hours over the length of the course for instruction, preparation/studying, or other course-related activities. For this course, students are required to devote a minimum of 640 hours to their internship assignment in order to earn 12 credit hours.

#### **Measurable Student Learning Outcomes**

This course, as with all courses here at Wichita State University, have measurable student learning outcomes. A student learning outcome is, essentially, an expectation of what a student will learn during a course, which includes skill building and critical thinking skills. Additionally, in an attempt to inform students of expectations I have included a list of assessments (activities, exams, etc.) that will measure or assess each specific student learning outcome. For our courses here in Sport Management, we are accredited from the Commission on Sport Management Accreditation (COSMA). COSMA accreditation stipulates we identify course content and student contact hours in regards to specific sport management-related program areas.

All programs in the College of Applied Studies are designed to be consistent with the college vision and a set of guiding principles. **The vision statement is to prepare candidates who are highly competent, collaborative and reflective professionals.** 

The following presents the Measurable Student Learning Outcomes and related assessment mechanisms needed to satisfy WSU-mandated accrediting processes.

- Utilize networking and job search skills to acquire location for internship. (Worksite Approval Form)
- Discuss and explain operational aspects of organization. (Weekly reports, Reflection paper)
- Apply knowledge gained in class to sport industry setting. (Weekly reports, Midterm and Final evaluations)
- Utilize and apply appropriate skills necessary to work effectively within formal and informal networks and work cultures (Weekly reports, Midterm and Final evaluations, Reflection paper)
- Explore and discuss how their experiences develops and enhances their career awareness. (Weekly reports, Reflection paper)
