Collect/analyze data; start writing findings; add to literature review</p> <p>Event: Proposal Defense (suggest no later than early October if plan to finish the following spring).</p>	<p>EL 999 Dissertation (6 hours)</p> <p>Emphasis: Continue writing; complete dissertation; review WSU Guide to Theses & Dissertations.</p> <p>Events: Submit Application for Degree (AFD) by 20th class day. ***Dissertation Committee composition:**

Advisor must have Dissertation Chair Status

Majority of members must be from the Department

Four members must have Full Status with the Graduate School

One member must be outside the Department and is designated as the Graduate School's representative

One member must be Practicing Professional with a terminal degree (this is unique to the EL Department because the EdD is a professional doctorate)
