KS BLUEPRINT FOR LITERACY AND SENATE BILL

- Senate Bill 438 was signed into law by Governor Laura Kelly on April 25, 2024. This bill established the Kansas Blueprint for Literacy and established an advisory committee to develop a plan for the creation of six Centers of Excellence in literacy across the state.
- The KS Blueprint for Literacy emphasizes a state-wide commitment to improving literacy outcomes.
- Focus on Structured Literacy, Science of Reading, and evidence-based practices.
- CLEAR aligns its mission with WSU's strategic plan and state priorities to meet legislative and educational goals.

CLEAR'S MISSION AND VISION

- CLEAR is dedicated to achieving the Kansas Blueprint for Literacy goal of having 90% of students reading at or above grade level by 2033. By leveraging WSU's unique position as Kansas's only urban-serving, public research university, we will facilitate meaningful impact through innovative strategies, community partnerships, and a focus on equity in literacy education across our catchment area.
- Mission: To advance literacy through evidence-based practices, professional learning, and family engagement.
- Vision: Equitable access to high-quality literacy instruction for all students in the catchment area.
- Focus: Collaboration with districts to support educators, students, and families.

GOALS

- I. Create a sustainable system of educator preparation that results in 100% of Kansas elementary teacher workforce achieving validated credentials in the Science of Reading and Structured Literacy, resulting in
- 2. 90% of 3rd through 8th grade students achieving level 2 or above, and 50% or more of 3rd through 8th graders achieving level 3 or above on the English language arts state assessment.




Figure 1. Framework and Pillars for CLEAR

Professional learning for educators (Structured Literacy, Science of Reading).


Family engagement and advocacy workshops.


Development of individualized literacy plans in collaboration with districts.
