- Follow-up for WSU-Tech Joint Senate Meeting
 - Executive committee is reviewing MOU and will recommend revisions.
- Senate record to University Special Archive
 - Prior to 2019, copies of the Senate and Exec Comm agenda/minutes were put in 3" binders and are stored in the Senate office. This consists of 21, 3" binders, 1987-2018. This information was digitized by the library in 2016–2017. All past and current volumes and documents are now available in SOAR, the WSU institutional repository and digital archive.
 - University Libraries has asked if they can store the physical binders in University Archives, which is in the Special Collections vault on the bottom floor of Ablah. The vault is climate controlled to protect the records, and the records would be readily available to anyone who requests them.

 - a. Change chair from Senate President to Past-President

Student Success Committee

Composition: 11

- 9 Faculty, one from each Senate division
- 2 students, one UG and one GR
- Stakeholders from relevant campus partners should be invited as needed to participate in discussions pertaining to their areas of responsibility to encourage cooperation and ensure transparency.

Selection: Members are nominated by the Rules Committee to be confirmed by the Senate

Structure:

- 1 chair elected by the committee
- 2 co-chairs to oversee URCAF

Charges:
