President's Report

- Kansas legislature has approved a proviso that all state institutions must comply with state law to receive funding, this includes not using pronouns in email signatures and no DEI positions or activities.
 - The senate executive team is working with the Provost and GC office to understand impact.

2025 KANSAS SENATE BILL No. 125-page 254 Sec. 161.

STATE FINANCE COUNCIL

(a) During fiscal year 2026, on or before August 1, 2025, the secretary of administration, in consultation with the governor's department, shall certify to the members of the state finance council

that all state agencies have:

- (1) Eliminated any positions that relate to diversity, equity and inclusion;
- (2) eliminated any mandates, policies, programs, preferences and activities relating to diversity, equity and inclusion;
- (3) eliminated any training requirements in diversity, equity and inclusion for any employee;
- (4) canceled any state grants or contracts relating to diversity, equity and inclusion; and
- (5) removed gender identifying pronouns or gender ideology from email signature blocks on state employee's email accounts and any other form of communication.
- (b) The secretary of administration shall present such certification and any additional information to the state finance council at a state finance council meeting.

Selection: Members are nominated by the Rules Committee to be confirmed by the Senate

Structure:

- 1 chair elected by the committee
- 2 co-chairs to oversee URCAF

Charges:
