Remote Work Policy Judy Espinoza, Rebecca Reiling, and Kelly Herzik	<ul> <li>Update on the Remote Work Policy; responding to feedback, employees working remotely in Kansas no longer need to file this form. The form has been broken up and shortened.</li> <li>Senators raised issues of process involving this and other recent policies HR has introduced (e.g. epaf automatic termination) without consultation of faculty or department chairs. Espinoza admitted this policy was an 'overreach' and is open to working with a reasonable group size to form policies.</li> <li>Senators raised issues about sabbatical travel and Fulbright Scholars to other states and countries. President Sternfeld-Dunn expressed his concern that scholarship should not be prevented based on where someone wishes to do research. Herzik said the goal isn't to limit research but to balance risk for the university.</li> </ul>	

	• Senators who are department chairs also indicated the concern of hiring adjuncts and this being a hurdle that would prevent rapid hiring in the last days before the semester "more bureaucratic hoops just to give someone \$2400 for one class."
