

FAREWELL TO DR. SNYDER

Nancy McCarthy Snyder joined the Hugo Wall School of Public Affairs faculty in 1977 and served as Wichita State University's director of institutional research from 1998-2000, associate vice president for Academic Affairs and Research from 2004-2007 and director of the Hugo Wall School from 2010-2016.

An economist by background, she was an accomplished researcher and professor when she took the helm as eighth director of the Hugo Wall School.

Her predecessors include professors Hugo Wall, Richard Zody, Glenn Fisher, John Bardo, Marjorie Taylor, Joe Pisciotte, H. Edward Flentje and John Wong.

As chief visionary, Snyder engaged community leaders to create collaborative relationships to advance the School's mission of integrating academic teaching, research and service.

A specialist in state and local government finance and social welfare policy, her research focused on the financing and effectiveness of education and human services, particularly issues of contracting and the privatization of child welfare in Kansas.

Under her dynamic leadership, the School quadrupled the amount of contract and grant funded research, successfully carried out a name change (from the Hugo Wall School of Urban and Public Affairs) and launched the Public Policy and Management Center (formerly known as the Center for Urban Studies). Snyder also spearheaded an exhaustive reaccreditation process.

After nearly four decades at the Hugo Wall School, she passes the baton to Dr. Sam Brown to continue to propel the mission forward in our community and worldwide. The entire Wichita State community is thankful for her profound contributions.

INSTRUCTION



MASTER of PUBLIC ADMINISTRATION

The Master of Public Administration degree provides instruction in public management, public finance and public policy that equips students with the knowledge needed to take on leadership roles in public and nonprofit organizations. Graduates serve as city managers, nonprofit executives, program managers, finance directors, budget analysts, management analysts and planners.

Faculty members have significant professional experience in state and local government and nonprofits. They also engage in research relevant to organizations in Kansas - bringing fresh perspectives on public management to the classroom.

CONTINUING EDUCATION

The MiniMPA: Executive Development in Public Administration is an intensive 16-week training series taught by faculty and area practitioners. Participants gain core public administration management knowledge to improve their ability to deal with complex challenges and to lead a workforce toward innovative solutions.

STUDENT PROJECT HIGHLIGHT

» HISTORIC FAIRMOUNT NEIGHBORHOOD

As part of our Community Networks course, student Adrienne McAlpine (MPA '17), participated in community conversations and planning in the historic Fairmount neighborhood just south of campus. The aim is to create healthy neighborhoods through increased activity, engagement and student achievement.

Many faculty, staff and students have been involved in the project, which is part of the Community Engagement Initiative grant from the Kansas Health Foundation designed to support resident-led efforts to improve health.

COMMUNITY SERVICE

The School's community service activities are completed by three centers: Public Policy and Management Center, Environmental Finance Center and Kansas Public Finance. The work of these three service centers complements the research activity of the School to expand and disseminate knowledge in the areas of public management, public policy, environmental finance and public finance that engages communities to solve problems in ways that serve the public good.

The Centers engage state and local governments and nonprofit organizations through professional development, applied research and technical assistance/consultation.

COMMUNITY SERVICE PROJECT HIGHLIGHTS

» ADVANCING WATER CAREERS

Hugo Wall School's Environmental Finance Center, through a grant from the Environmental Protection Agency, created a classroom module and summer internship program for high school students to increase knowledge and stimulate interest in water and wastewater careers. Two advanced biology classes from El Dorado High School participated in hands-on learning sessions and tours of the water and wastewater treatment plants. As a result, one student completed an internship with the city's Public Utilities Department. This pilot school-community partnership will inform the rest of the project, which includes an additional seven high schools and four internships.

» CITY OF WICHITA FIRE DEPARTMENT

The Public Policy and Management Center assisted the City of Wichita Fire Department with a deployment study to address non-emergent medical calls that account for a significant increase and proportion in the number of responses by the fire department. The PPMC conducted national research and provided examples of alternatives used by other communities to address non-emergent medical calls and policy considerations. Stakeholder groups were engaged both internally and through an advisory group that included policy makers, public safety agencies and the healthcare industry. As a result of the research, the Wichita Fire Department is implementing a pilot deployment project based on the findings.

RESEARCH

Faculty and staff of the Hugo Wall School are actively engaged in the creation and application of knowledge in fields of public and nonprofit management, public finance and public policy. Faculty conduct academic research and publish their findings in a number of outlets. They also work with the three Centers to produce applied research, professional consultation and technical assistance for state and local governments and nonprofit organizations.

RESEARCH PROJECT HIGHLIGHTS

» EFFECTS OF ABANDONED HOUSING

Hugo Wall School's Public Policy and Management Center assisted the City of Topeka's Department of Neighborhood Relations to conduct research on the impact of abandoned housing.

The study explored the effect that abandoned housing has on the property value of comparable homes, adjacent homes and those within the same city block. Public safety was also studied to analyze police and fire response on blocks with abandoned housing versus those without. Stakeholders were engaged to qualify the effects of blight on neighborhood members. The City of Topeka uses the results of our research to inform local and state policy conversations related to blight and abandoned housing mitigation.

» DRUG COURT PROGRAM EVALUATION


Dr. Melissa Walker worked with a team of graduate students to document the drug court process in Reno County. The drug court, an alternative to incarceration that involves drug treatment, intensive supervision and regular court appearances, began in 2012 with funding from the Bureau of Justice Administration in the U.S. Department of Justice.

The evaluation team interviewed substance abuse treatment providers, community corrections staff and court officials. During the year-long evaluation, our team analyzed court hearing observations and data obtained from the Kansas Department of Corrections. The county drug court manager plans to use the evaluation as a tool to increase project outcomes.

>> GROCERY SALES TAX RESEARCH

The Kansas Public Finance Center at Hugo Wall School conducted research about the effects of the state sales tax on groceries. Commissioned by KC Healthy Kids, a nonprofit children's health advocacy group, the study received substantial national media attention including by NBC News. Findings were also discussed in state legislative working sessions.

Drs. Kenneth Kriz and Arwiphawee Srithongrung completed a series of four white papers which concluded: the burden of the grocery sales tax falls most heavily on lower-income households; rural food stores are negatively impacted; shoppers cross the state line to buy groceries and replacing the grocery tax with increased income tax would have a positive economic effect on the state's revenue.

PUBLIC POLICY AND MANAGEMENT CENTER (PPMC)

The Public Policy and Management Center works with state and local governments and nonprofit organizations to address issues impacting citizens, communities and states. The PPMC assists in meeting the challenges of local governance and improving service delivery through applied research, professional development, community engagement and technical assistance/consultation to create and apply knowledge and to expand the reach of community service on behalf of the public.



ENVIRONMENTAL FINANCE CENTER (EFC)

Professional training, technical assistance and applied research are provided through a collaborative approach with partner organizations to meet the challenges of community environmental issues. The EFC serves elected officials, state and local governments, community organizations and professional associations in Kansas, Missouri, Nebraska and Iowa on topics such as water system sustainability, energy conservation, asset management and financial capacity.

FACULTY



>> MARK A. GLASER, PH.D. professor

Dr. Glaser's research encourages actions on the part of public agencies consistent with public interest and citizen commitment to community wellbeing. He is the lead author of a research paper presented at the 8th Sino-US International Conference for Public Administration in Beijing, China. Glaser is involved in citizen survey research to guide strategic public investment decisions in Bel Aire, Kan. He is also assisting WSU President John Bardo in drafting a white paper that articulates the logic behind the Wichita State's Innovation Campus. In addition, Glaser is involved in a community development survey of the Fairmount neighborhood sponsored as part of the Shocker Neighborhood Coalition, sponsored in part by the Kansas Health Foundation.



>>> KENNETH A. KRIZ, PH.D. Kansas Regents Distinguished Professor director. Kansas Public Finance Center

Dr. Kriz published two co-authored academic journal articles: "Debt Burden and Perceived Sovereign Default Risk: Evidence from Credit Default Swaps" in Public Finance and Management and "The Effect of Board Composition on Public Sector Pension Funding" in the Journal of Public Budgeting, Accounting, and Financial Management. He received the prestigious Jesse Burkhead Award from the Association for Budgeting and Financial Management for his article "The Two Worlds of Municipal Bonds: Are Lower Rated Bonds Punished More by Financial Crisis?" in Public Budgeting and Finance. In addition, Kriz completed work on four research projects and continued his appointment on the Board of Trustees for the City of Wichita Police and Fire Retirement System.



SAMUEL L. BROWN, PH.D. professor director, Hugo Wall School of Public Affairs

Dr. Brown joined the Hugo Wall School in July 2016 as director and professor. His primary research involves studying social, economic and health disparities. His current research efforts include developing theoretical frameworks and practical guidance to further understand how American institutions continue fostering current barriers in achieving the democratic ideal of social, economic and political equality for all. Brown's most recent publication on the issue of inclusion of diverse student populations appears in the fall 2015 edition of the peer-reviewed *Journal of Public Affairs Education*.



» ARWIPHAWEE SRITHONGRUNG, D.P.A. associate professor

Dr. Srithongrung presented two research projects, "Allocative Efficiency across Service Functions: Are V.O. Key Criteria Fruitful?" and "Local Governments' Optimal Tax Level: How High is Too High" at national and international academic conferences; both are under review by leading public administration journals. She completed "Sales Tax Rate Differentials and Cross Border Shopping in Kansas," part of a series of four white papers on the effects of Kansas' taxation of grocery sales. The research received regional and national attention and was discussed in state legislative working sessions. Srithongrung provided expert advice regarding state government budgets and supplementary spending to the Volcker Alliance, a non-partisan public policy organization; her contribution appears in their report Best Practices in State Budget Transparency.



>> SAMUEL J. YEAGER, PH.D. professor

Dr. Yeager compiled an Index of the Municipal Finance Journal published on one of that journal's websites. He sits on the editorial boards of numerous journals including: Public Administration Quarterly; International Journal of Public Administration; Public Budgeting, Accounting & Financial Management; Journal of Health and Human Resources Administration and International Journal of Organization Theory and Behavior. Yeager serves as a reviewer for the American Review of Public Administration. He has completed 18 reviews for these journals. In addition to his duties as graduate coordinator for the Hugo Wall School, he serves on the Wichita State University Faculty Senate and its Scholarship and Student Aid Committee.



>> MELISSA A. WALKER, PH.D. associate professor

Dr. Walker was part of an interdisciplinary effort across WSU departments to establish a graduate certificate in Museum Studies. She will teach a course on nonprofit fundraising and financial management. Walker also directed a group of graduate assistants in a ridership study for Wichita Transit, presenting a final report to Transit officials. Working with Criminal Justice faculty, she conducted a training session to help Sedgwick County crime prevention and liquor tax grantees learn how to measure the results of juvenile crime prevention and substance abuse treatment programs. In addition, she coordinated preparation of our self-study for Network of Schools of Public Policy, Affairs, and Administration (NASPAA) in order to receive reaccreditation.
