### **Elwin Barrett Fund Doubles at POWER Conference**

Empowerment reigned at this year's POWER Conference as many participants chose to help the School of Social Work by donating to the Dr. Elwin Barrett Social Work Fund. Dr. Barrett retired from the faculty in the spring of 2007 and the Fund has been established to honor his more than 30 years of service to the School, including 24 years as Director.

When the fund has reached \$15,000, it will be permanently endowed. Nearly 10% of that amount was donated or pledged at the POWER Conference on March 28<sup>th</sup>. An endowment becomes the principal of the Fund; the interest from that principal will be used to benefit the School. The money raised in March almost doubles what was previously in the Fund, for a total of \$3,090.

Many POWER Conference participants

may have left believing that \$765 was raised that day. However, once pledges and last minute donations were counted, the amount reached a gratifying \$1490!

Currently, the fundraising effort is being spearheaded by the School of Social Work's Advisory Board. By endowing the Fund, the Advisory Board would like to continue Dr. Barrett's legacy of commitment to students, faculty, the community and his chosen profession of social work. In the future, the Fund may be used for student scholarships, faculty training and research, or teaching materials for the School. The ultimate beneficiary will be the students and the communities they will be better educated to serve.
