

KEYNOTE SESSION

"Can We Do It? Yes We Can!: Constructing an Ethical Approach to HIV Care in the Future." Dr. Donna E. Sweet, MD, AAHIVS, MACP Professor, Medicine and Director, Internal Medicine Education

Via Christi Regional Medical Center -St Francis Campus

Dr. Sweet is a native of Wichita and a graduate of Wichita State University and The University of Kansas School of Medicine. She is a Master in the American College of Physicians and is the Immediate Past

Chair of the American College of Physicians Foundation Board as well as Chair Emeritus of the American College of Physicians Board of Regents. She is also an AMA delegate for the ACP and is a member of the council on Medical Service of the AMA.

Dr. Sweet is certified as an HIV specialist by the American Academy of HIV Medicine of which she is the current board Chair national Co-Chair of the CDC HRSA AIDS Advisory Council (CHAC). She has an HIV program in her clinic with Ryan White Parts B, C and D and is also the Principal Investigator and Director of the Kansas AIDS Education and Training Center.

Dr. Sweet cares for approximately 1000 patients with HIV in her clinic in Wichita and in 3 outreach clinics in rural Kansas. She accomplishes this with the help of a team of experienced social workers, nurses and

Hello from Field Practicum! We are off to an exciting 2011, and think that our upcoming graduates will be prepared by the wonderful learning experiences they



are provided by our community agencies and organizations. This could not happen without you who serve as field instructors, and we are so grateful for your time, expertise, and willingness to share this with our students.

New to the Field Practicum team is Shaunna Millar, LMSW, who is our new Associate Director of Field Practicum. Shaunna Millar has been a social worker in Sedgwick County for fourteen years, receiving both her BSW and MSW degrees from Wichita State University. She has worked primarily in the areas of child welfare, mental health, and corrections. Her experiences include working as a social worker with the Exploited &

Missing Child Unit at SRS, the YWCA Women's Crisis Center, and Sedgwick County Department of Corrections at the Juvenile Detention Facility (JDF). Most recently, she worked providing outpatient individual, family, and group therapy at Youthville Family Consultation Service. The BSW program has had many great things happening and a new group of students are ready to enter the program. The BSW Orientation sessions were held in early February and we anticipate there will be about 80 new applicants to the program this semester. We finalized our new and improved BSW curriculum and information on new course offerings and changes to the BSW structure have been included in the communications with students. We developed a new course entitled Social Diversity and Ethics, ScWk 304, that will supply students with the required diversity class they have always had but will no longer have to seek the diversity content from other departments around campus. This course was also approved as a General Education Further Studies so this means there will be students outside of Social Work who come to take our class to meet University degree requirements. School of Social Work Summer Electives

ScWk 610O; Biblio-Interventions for Social Work Practice; 1 credit; CRN 38334; Shaunna Millar; May 31 - June 3; TWThF; 8:00-11:45 am; main campus This course provides an introduction to creative, book-based intervention strategies for use in social work practice, focusing on both children's and adult literature. Students will explore how individuals, groups, and communities can all be empowered through the use of fictional stories, and engage in hands-on activities in the classroom firsthand.

ScWk 730G; Spirituality and Social Work Practice; 3 credits - CRN 38336 - Dr. Fred Besthorn

June 7 - Jun 30; Tuesdays, Wednesdays & Thursdays; 9:00 am - 12:30 pm; main campus

This course provides a framework of knowledge, values, skills and experiences for spiritually-sensitive social work practice. A comparative approach to teaching about religious and spiritual diversity is employed in order to provide understanding of diverse perspectives and to foster self-awareness of the student's spiritual commitments and their congruence with professional values.

ScWk 610Q - Animal-Human Connection - 1 credit - CRN 38337 - Sabrina Perez Glatt

June 10 & June 17; Fridays; 9:00 am - 4:00 pm; west campus

This course explores the connection between humans and animals and its use in social work practice. Students will learn how this connection can be used effectively in various therapeutic and population settings, including animal companion and activity programs.

ScWk 730I - Clinical Interventions with Children & Adolescents - 3 credits - CRN 38340 - Sherry Chapman

July 5 - July 28; Tuesday, Wednesday & Thursdays; 1:00 pm - 4:15 pm; west campus This class provides an overview of advanced social work techniques in working with children and adolescents.

ScWk 870 - Clinical Assessment for Advanced Generalist Practice - 3 credits - CRN 38074 - Dr. Orren Dale

July 5 - July 28; Tuesday, Wednesday & Thursdays; 5:30 pm - 9:00 pm; west campus

The course uses a biopsychosocial perspective to understand problematic patterns of functioning identified as diagnoses in the DSM-IV. Students critically examine the DSM-IV as a basis for social work assessment and learn its use within an advanced generalist practice perspective.

ScWk 610P - International Social Work - 1 credit - CRN 38338 - Dr. Kyoung Lee

July 8 & July 9; Friday & Saturday; 9:00 am - 4:00 pm; main campus

This course provides an overview of micro and macro practice outside of one's own culture and internationally that will facilitate skill development in cross-cultural assessment and intervention at the individual, group and community level.

ScWk 610W - Social Work Practice with the Aging - 1 credit - CRN 38339 - Dr. Kyoung Lee

July 22 & July 23; Friday & Saturday; 9:00 am - 4:00 pm; main campus

This course focuses on the psychosocial, biological and environmental aspects of current social work policy and practice with the aging population.

Examines critical topics related to the elderly such as loss, care giving, mental health, sexuality, elder abuse, Medicare and alternative housing needs.

Interested in taking one or more of our elective courses, but already have your degree?

You don't need to be one of our students to take our elective courses. People often take our courses for professional or personal development or licensing requirements. If you aren't currently a WSU student, you will need to be admitted to WSU as a non-degree seeking student at either the undergraduate or graduate level.

Courses numbered between 500 and 799 can be taken for either undergraduate or graduate credit. In order to take courses numbered 800 or above, you must be admitted to the Graduate School. Be aware that if you take a course for undergraduate credit, you will not be able to apply that as graduate credit or toward a graduate degree in the future.

The application process is simple.

Applying as an undergraduate non-degree bound student:

Submit the simple 2-page application form with the application fee to WSU Admissions. You can download the form or apply online on the WSU Admissions website at www.wichita.edu/admissions. Enter the major code for non-degree bound "K10B" on the application form.

You do not need to submit transcripts to be admitted as an "open admission" non-degree bound student. Once you accumulate 15 credits under that status, you will need to have transcripts sent to WSU to become a regular non-degree bound student.

Applying as a graduate non-degree bound student:

Submit the simple 1-page Graduate School application and the application fee to the WSU Graduate School. You can download the form or apply online on the Graduate School website at www.wichita.edu/gradschool.

Have official transcripts sent directly from your universities to the Graduate School. (If the last school you attended was WSU, they will already have your transcripts and you do not need to request them.)

Graduate School offers two levels of non-degree admission:

Non-Degree Status A (major code G46S) allows you to take any graduate level courses numbered 500 and above. The requirements are a bachelors degree from an accredited university and a minimum 2.75 GPA over the last 60 graded credit hours of course work.

Non-Degree Status B (major code G66S) allows you to take graduate level classes numbered 500-799. The only requirement is to have a bachelors degree from an accredited university. There is no GPA requirement.

Drug Addiction Counselors Association, Clinical Director for programs at Central Kansas Foundation in Salina, KS and at Pawnee Mental Health in Manhattan, KS. Michael has taught as an adjunct faculty for Kansas Wesleyan University's Behavioral Science Department. He worked as a Marriage and Family Therapist, Sex Therapist and Addictions Counselor at Prairie View, Inc. in Newton for over 15 years. In addition to his current position as a therapist with Correct Care Solutions, contracting with the Kansas Department of Corrections, he shares a private practice providing group, individual and couple therapy with Margaret Goger-Cranston, LSCSW. Trauma is now understood to be an almost universal experience of public mental health and substance abuse and social service consumers, according to the National Center for Trauma-Informed Care (created by SAMHSA's Center for Mental Health Services). This presentation will highlight the prevalence of trauma in the lives of many people who access social service systems and will explore some of the core elements in creating treatment partnerships based on collaboration, choice and consumer/survivor perspective. Presenters: Teresa Strausz, LMSW; Chris White, CPS and Christine Young, CPS, Wichita State University Center for Community Support and Research

D. Youth Substance Misuse Prevention: Advocacy, Education, Networking This will be an interactive session that explores addiction social work practices with-

Too Hot, Too Cold or Just Right: Ethical and Clinical Challenges in the Treatment of Couples with Sexual Desire Differences

The most common sexual complaint couples will present for therapy is a difference in interest and preferred frequency of sexual relations. It can also be one of the more difficult problems for the therapist to address. The presenters will discuss various ways this complaint is presented, the numerous factors that can contribute to differences in desire, the risks for pathologizing lower or higher levels of interest and other ethical considerations. F. Medical Foster Homes: The Support at Home Initiative

This session will offer information about the new initiative the Veteran's Health Administration is offering Veterans. Veterans now have another option for Long Term Care - A Medical Foster Home

(MFH). The initiative, Support at Home: Where Heroes Meet Angels, benefits the Veteran and Caregiver who provides 24/7 care in the home environment. G. Ethics and End-of-Life Care

As our population ages and palliative medicine advances as a philosophy of care, health professionals will be faced with increasingly complex end-of-life decisions. Knowing the "whole patient" allows a position where ethical approaches can be made. This session will provide an overview and promote a basis for discussion of the ethical concerns involved in End-of-Life care, including how much care, what kind of care, and when to stop medical care. Presenter: Jerry Old, MD, Associate Professor of Family and Community Medicine at the University of Kansas School of Medicine - Wichita

(Session participants will earn 1.8 units applicable to meeting the 3 units of Professional Ethics required for social work re-licensure)

H. Advanced Directives: Challenges and Changes

This session will be a discussion of the challenges of advance directives. For example, why patients do not complete these documents before a healthcare crisis and what solutions are being tried to promote advance care planning. DEAF AND HARD OF HEARING ISSUES

Presentation Summary: The deaf community has a growing need of social workers and the services they provide. This workshop will help the social worker understand the cultural background of the deaf community as well as provide resources and knowledge about various kinds of technology.

Learning Objectives: This presentation will help Social Workers: 1) increase awareness of the deaf and hard of hearing population and their unique needs; 2) develop an understanding of how to utilize technology and sign language interpreters to better serve the deaf community; 3) identify appropriate resources within the community for agency use and for client referrals.

Presenters: Erin Haag became deaf at the age of 18 months. She learned Signing Exact English and received her hearing aids on her 2nd birthday. Since then, she has become a state certified sign language interpreter in both American Sign Language and transliterating. While Erin spent 12 enjoyable years interpreting for Music Theatre of Wichita, she has focused her work in the Early Childhood Special Education classroom and working with families and toddlers affected by deafness. In 2008, Erin decided to return to school to pursue another area of interest: Social Work. She will graduate from the Wichita State University School of Social Work with her Bachelors of Social Work in May 2011 and plans to pursue her focus of working with children and families. Erin lives in Maize, KS with her husband, Mike, and in between classes and practicum is learning to sew and working with her dog, Ginger, to become a certified hearing dog.

Amy Fowler began working as a contract interpreter and transliterator at Wichita State University in 1995. From there, she joined a local community agency, Sign Language Interpreting Services, which was founded in 2000. Amy began working with Sorenson Video Relay Service when the Wichita center opened in summer 2009, and became a staff interpreter with WSU fall 2009. She completed her Bachelors of Art in Sociology with an emphasis in Psychology and Communication in December 2010, and is considering Grad School in Sociology fall 2011. Amy holds interpreting certification from the State of Kansas, is currently serving as the secretary for KAI-RID, and is an associate member of RID - with an eye on the NIC in the near future. She has a strong philosophy of life-long learning, and LOVES working at the university level. Amy lives in Wichita with her partner, Kim, and their small zoo of dogs and cats. In her spare time, she reads, knits, watches movies and is a bona fide Gleek.
