

Over the past two years, we have worked very hard to review and, when necessary, revise our curriculum and program. We look forward to the completion of this process, and we are "hopefully optimistic" about the outcome. Our program and graduates give us much to be proud of, and this accreditation process provides the opportunity for sharing our accomplishments with the Site Team and with the Council on Social Work Education.

We are also looking forward to the Fourth Annual POWER Conference. The theme for this year's conference comes from one of the four themes of the MSW Program: Social Justice. This year, the Conference will focus *on Social Work*

The POWER Conference has provided a forum for showcasing the four themes of the MSW Program. These themes are the bedrock of Advanced Generalist Practice as described in our vision of social work practice for our metropolitan setting. The launching of the MSW Program in 1999 was only possible because of the continuing successful accreditation of the BSW program and the ongoing leadership provided by Dr. Barrett. We will be honoring Dr. Barrett in a farewell reception later this semester, so stay tuned for more details on that event too! Until then, I know that you all join me in expressing profound gratitude for Dr. Barrett's commitment to the School and for his unparalleled impact on countless students over the past 30+ years.


As one of our field instructors has recently said, "My student keeps me on my toes. She keeps me up with what is new in social work and helps me stay excited about the profession like I was when I was a student."

Tribute to Dr. Elwin Barrett

Dr. Barrett has served Wichita State University for over 30 years, and his record of excellence in teaching and service is exemplary. For twenty-four years, Dr. Barrett served as the Director of the Social Work Program. Under his



leadership, the program received its first accreditation, making the WSU social work program one of the first BSW programs in the country to achieve accreditation.

As a clinical social worker, Dr. Barrett brought a skills base and vision to the School that is still apparent in our emphasis on competent, ethical, and empowering practice skills. He used his considerable experience in neuropsychiatric services and group-oriented services as the basis for developing the foundation practice methods portion of our curriculum. As a practice methods instructor, Dr. Barrett is respected and beloved by students, who value his commitment to their learning and to modeling the clinical skills and values he teaches. Within the Wichita area, there are literally hundreds of social work practitioners who trace their professional development from the skilled and caring instruction they received from Dr. Barrett.

Dr. Barrett received a certificate in

Teaching of Human Sexuality in 1978, and since that time, many hundreds of students have taken his course on Human Sexuality. The fact that this course has been taught without incident and with consistently high enrollments is a testament to Dr. Barrett's exceptional teaching skills. Over the years he served as Director of the BSW Program. Dr. Barrett taught virtually every course in the undergraduate curriculum, and his commitment to students is evident in the comments of community practitioners, who never fail to ask if Dr. Barrett is still a member of the faculty, and who express gratitude for the impact he had on their careers and learning.

In addition to the influence he has had on curriculum and students, Dr. Barrett has had a lifetime commitment to service. He has served the University in countless roles and he has served the community and the social work profession in a myriad of ways.

Dr. Barrett has a long and distinguished record of service to the community and to the profession of social work. In December of 2004, he was honored by the Association of Social Work Boards as a past president of this organization and for his role in helping to develop licensing standards for social workers. In this regard, Dr. Barrett was awarded the Distinguished Service Award by the American Association of State Social Work Boards in 1984. He has devoted much of his academic and professional career to improving the pro-

fession through developing professional standards that are enforced and monitored through state licensing of social workers. Within the state of Kansas, for over twenty-five years, Dr. Barrett has served as president or treasurer of the Kansas Council on Social Work Education. In this capacity, he has contributed to the growth and success of social work programs across the state. He has initiated and modeled a collaborative approach in working with programs across the state to achieve mutually beneficial goals. He is both beloved and respected as an expert on accreditation and program planning.

Dr. Barrett has a longstanding commitment to the Wichita community, as demonstrated by his role as advisor and consultant to community groups, such as his work with the Inter-Agency Truancy Advisory Committee, the Advisory Council of the National Conference for Community and Justice, and the Community Consultation Board for Human Sexuality and AIDS Education for USD 259.

Dr. Elwin Barrett exemplifies the ideals of higher education in his commitment to students, faculty, the community, and to his chosen profession of social work. He embodies the values of free inquiry, the growth and sharing of knowledge, and life-long learning and service to others. We are sad to see him leave, but we wish him every happiness as he moves on to another productive and highly rewarding phase of life!

A Day in the Life of a WSU Grad Karen Dodson

Karen L. Dodson earned her MSW in May 2006 from Wichita State University's School of Social Work. Her graduate practicum at the Robert J. Dole Veterans Affairs (VA) Medical Center gave her valuable real-world



experience in case management, rehabilitation, long-term and end-of-life care working with Veterans surviving post-traumatic stress disorder, amputation and other conditions in a forty-bed care unit.

Karen accepted a fellowship position at Yale University in association with the VA in Connecticut, where she offers clinical case management to hundreds of Veterans. She facilitates several psychoeducational groups which she has developed and implemented, including: Grief & Loss, Healthy Living, Smoking Cessation, and an Art Workshop at the VACT Ererra Community Care Center (ECCC). Veterans living with serious mental illness especially benefit from her compassionate work

Her synergy work with ECCC Veterans participating in her Grief & Loss group continues to be an inspiration; she will be presenting a workshop on the importance of healing through grief as an integral part of psychosocial recovery at the 2007 United States Psychosocial Rehabilitation Association (USPRA) Conference in Orlando, FL.






