- 2. Final review step to occured April 2018. Waiting for results.
- 3. ABET, Inc. policy prohibits public disclosure of the period for which a program is accredited, though institutions may publish the year of the last and next review.
- 4. Associate membership granted April 2011 with annual reporting requirements. Next full review in 2017-18.
- 5. At its March 2018 meeting, the Accreditation Review Commission on Education for the Physician Assistant (ARC-PA) placed the Wichita State University Physician Assistant program sponsored by Wichita State University on Accreditation-Probation status until its next review in March 2020. Probation is a temporary status of accreditation conferred when a program does not meet the Standards and when the capability of the program to provide an acceptable educational experience for its students is threatened. Once placed on probation, programs that still fail to comply with accreditation requirements in a timely manner, as specified by the ARC-PA, may be scheduled for a focused site visit and/or risk having their accreditation withdrawn. Specific questions regarding the Program and its plans should be directed to the Program Director and/or the appropriate institutional official(s). A focused probation site visit is schedule for October 7-8, 2019.
- 6. Additional reporting requirements submitted September 1, 2017, awaiting response.
