On behalf of the **Office of Financial Aid & Scholarships**, I am honored to present the 2024-2025 Annual Report. Guided by our mission of access, affordability, and student success, this year has reaffirmed our commitment to supporting students from the moment they first consider Wichita State University through each stage of their academic journey.

Despite continued uncertainty, especially delays in the FAFSA process, we achieved **record levels of support**. More aid was disbursed to more students than ever before in WSU's history. This achievement would not have been possible without the persistent, compassionate work of our team, who helped students and families navigate complex policies and processes to ensure that our service was always centered on those we serve.

This year, our programs have focused on ensuring that financial aid opens doors: providing need-based aid for students with true financial barriers; awarding merit-based scholarships to recruit and retain academically outstanding students; and coordinating with all university partners to maximize impact. Together with University leadership, Academic Colleges, the WSU Foundation, and Financial Operations, we strengthened collaborations to ensure equitable, timely disbursement, reconciliation of aid funds, and robust accountability.

Key highlights from the year include awarding over \$128 million in aid to more than 12,000 students, processing upwards of 33,000 financial aid applications, and refining our internal policies and systems to better serve students. As we share this report, I invite you to reflect on how each number represents a student's dream, a family's perseverance, and a community's shared investment in higher education.

Looking ahead, we will build on this momentum - continuing to enhance policy clarity, streamline technology, strengthen partnerships, and remain responsive to legislative and regulatory changes. Our focus remains resolute: to make WSU a place where potential is not limited by circumstance.

Thank you to all who partnered with us - students, staff, faculty, community stakeholders, & policy makers - for your trust and collaboration. Together, we will continue to move forward.




Financial aid is any grant, scholarship, loan, or paid employment offered to help students meet their college expenses.


Aid is usually provided by various sources such as federal and state agencies, colleges, foundations, private donors, and corporations.


LOAN SCHOLARSHIP GRANT WORK STUDY

Shocker Financial Wellness helps students gain awareness and confidence about personal finances so that they can make smart financial decisions during and after college. We offer free support through workshops, tabling, peer advising, and classroom presentations. These resources are intended to connect students with tools and skills to learn about budgeting, money management, responsible borrowing, credit, and more.

Having control over one's finances can help students reach their financial goals and reduce stress or anxiety, while also positively impacting their academic performance. With resources to maintain healthy finances, students can focus on continuing to pursue their degree.



The Office of Financial Aid & Scholarships hosted our third Shocker Promise Academy, an exclusive program for our Shocker Promise Scholars. This program took place Aug. 5th to 9th.

The Shocker Promise Scholarship was established in 2021 as a last payee award exclusively for our Shocker Neighborhood students. As of today, the scholarship program has expanded to include all Kansas residents who qualify. Eligible students must be Kansas residents, have a minimum unweighted 2.5 high school GPA, and an annual family income of less than \$60,000.

Students who are awarded the Shocker Promise scholarship have an opportunity to attend Shocker Promise Academy, a week long retreat, prior to the start of fall classes. Shocker Promise Academy focuses on introducing students to oncampus resources/opportunities, connecting with other Promise Scholars, and take a free 3-credit-hour course that introduces students to core skills needed to be a successful college student.









"Shocker Promise helped me get involved with the Study Abroad program; it pointed me in the right direction of who to contact to do the things that I wanted to do. It also took off some of my financial burden by paying the tuition, which was a lifesaver.

Scholarships

Recognizing excellence in and outside the classroom.

Definition

Scholarships are gift aid (no repayment required) based on academic or other merit-worthy achievement, but in some cases, financial need may also be considered.

General Scholarships

Incoming/new students are awarded through Merit Scholarships, the Distinguished Scholarship Invitational (DSI), and other programs and specific scholarship applications.

Continuing/current students are awarded through renewals and recommendations from each academic college or a scholarship organization.

Academic College Scholarships

Colleges award over \$5 million annually and are coordinated with the OFA to ensure compliance with federal regulations.

Athletic

The Athletic Department awards over \$4 million in grant-in-aid and coordinates awards with the OFA to ensure compliance with NCAA regulations.

Dept. & Campus Organizations

These scholarships are awarded through departmental funds, student fee allocations, and/or grants.

Outside Scholarships

These scholarships come from external organizations and exceed \$4.4 million annually.



Need-based aid to help limited income students.

Definition

Grants are gift aid (no repayment required) and are generally awarded to undergraduate students who demonstrate significant financial need based on filing the FAFSA.

Types of Grants

While the Federal Pell Grant is the most common program, the OFA also manages the Federal Supplemental Educational Opportunity Grant, the Federal TEACH Grant, the Kansas Comprehensive Grant, and Wichita State's institutional grant program: Shocker Promise...

Pell Grants

To remain eligible for their grants, students must begin academically related activity in all of their courses, must be making Satisfactory Academic Progress, and for the Pell, SEOG, IASG, or Kansas Comprehensive Grant, cannot have previously earned a bachelor's degree.

The amount of their award is based on their Student Aid Index (SAI) from the FAFSA, as well as their eligible, enrolled credit hours on the Financial Aid Recalculation Date (often corresponds with each semester's last day for 100% tuition refund).

Need-Based Programs

Shocker Opportunity Fund

Designed to help qualifying students through small, unexpected financial emergencies.

Shocker Completion Grant

Designed to help students with necessary educational expenses who are in their final 24 credit hours and who have exhausted other forms of financial aid - including loans.

Shocker Book Scholarships

Designed to help students with the purchase of required textbooks once they have exhausted other forms of financial aid.



Self-help aid that must be repaid over time.

Definition

Loans are considered self-help aid, as the funds must be repaid. When used responsibly, they can be an effective option for students and families to meet educational costs.

Types of Loans

The OFA Post-Award team administers the Federal Direct Loan programs, which includes Subsidized, Unsubsidized, and PLUS Loans, and also certifies alternative educational (private) loans.

Subsidized

Awarded based on financial need. Students are not responsible for the interest while they are enrolled at least half-time.

Unsubsidized

Not based on financial need and will begin to accrue interest once the loans are disbursed.

Parent PLUS

Credit-based, fixed-interest-rate loans available to parents of dependent students.

Grad PLUS

Credit-based, fixed-interest-rate loans available to graduate students after they have used their annual unsubsidized loans.

Federal Direct Loan Program

Wichita State participates in the Federal Direct Loan Program. The U.S. Department of Education (ED) acts as both lender and guarantor for Direct Loans, so only two agencies are involved: the federal government and the university. The university originates loans and disburses students' loan funds when they have been approved. Repayments are made to an ED Federal Direct Loan Servicer.

Work Study

Earning a paycheck and valuable work experience.

Definition

Work study, which is considered self-aid aid because students work for the financial aid funds, enables students to work alongside university professionals to gain valuable work experience in an environment that cultivates their professional skills, but also recognizes that first and foremost, they are students.

Student Employees

While participation in the Federal Work Study program requires financial need, departmental employment is available to students regardless of financial need, and in those hiring cases, the student's wages are paid entirely by the hiring department.

Where Does the Funding Come From?

Federal Work Study is funded 75% by the federal government, and 25% by the institution.
Awards to students are based on financial need.

Federal Work Study Student Profile

"When I began attending Wichita State University, I was concerned that I would be lost after graduating when it came to the professional world. I'm a busy student, so getting acclimated to such a scene before graduating didn't seem like a possibility for me. Since I started working at the Office of Financial Aid & Scholarships as a federal work study student, I've had the opportunity to grow professionally while while working towards my degree.

I feel very lucky to work in an environment where being a student comes first. It allows me to build my work schedule around my academic and personal needs and have supervisors who are dedicated to helping me understand what it's like to work in an office environment. Thanks to the Federal Work Study program, breaking out into the workforce after I earn my degree is much less daunting now that I have skills and experience that I can bring with me to future careers."


