SECTION F: REQUIRED FINANCIAL DOCUMENTS

IMPORTANT NOTE: The above estimated amounts include tuition, fees, accommodations, meals, books, and medical insurance. The estimate is based upon full-time enrollment of 12 credit hours per semester (9 credit hours for graduate students). These amounts are averages and may vary from student to student. Actual expenditures depend on: 1) the student's major and credit hours enrolled, 2) the residence hall or apartment in which the student lives, 3) whether or not the student has a roommate, and 4) the student's meal plan.

REQUIREMENTS FOR STUDENTS SPONSORED WITH FUNDS FROM A BUSINESS BANK ACCOUNT:

- 1) A bank statement AND sponsorship letter must be included with this document. View sample sponsorship letter at <https://wichita.edu/CompanySponsorship>.
- 2) The sponsorship letter must indicate that sponsorship will be for the total amount listed in Part C or D above for each year of study at Wichita State University.
- 3) The sponsorship letter must be on company letterhead and be signed by an authorized company official.
- 4) The bank statement must be on bank letterhead and list the name of the business as the account holder.
- 5) Bank statement may be in any currency.
- 6) Bank statement and sponsorship letter must be dated within the last 6 months.
- 7) All documents must be in English. If not in English, the documents must be accompanied by a translation that has been signed/stamped by the official translator.

REQUIREMENTS FOR GOVERNMENT, AGENCY, SCHOLARSHIP, OR ORGANIZATIONAL SPONSORSHIP

- 1) A nomination letter or prospective financial support letter on the organization's letterhead must be attached to this form.
- 2) If bringing a spouse or children, the letter must indicate that they are covered.
- 3) If a spouse and/or dependent children will accompany you to the U.S., complete Section G of this form.
- 4) All documents must be in English. If not in English, the documents must be accompanied by a translation that has been signed/stamped by the official translator

SECTION G: DEPENDENTS

If your spouse or dependents will accompany you to the U.S., your bank documents must show that you have additional financial resources of \$4,000 per year for your spouse and each dependent. Except for students on J-1 visas, medical insurance coverage is not required, but is highly recommended, for your spouse and/or dependents. The cost for spouse/dependent medical insurance coverage is an additional amount not covered in the \$4,000 estimate per year. The following items are required:

- Provide a passport copy for each dependent.
- List your spouse (husband or wife) ONLY IF he or she will be on an F-2 (dependent) visa .
- Do not list any children who are U.S. citizens, married, or 21 years of age or older.
- Do not list your parents or any other relatives on this form.
