#### Articulation Agreement

#### Purpose

This agreement is to facilitate the transfer of students between Hutchinson Community College (HutchCC) Honors Program and the Wichita State University (WSU) Dorothy and Bill Cohen Honors College. This Articulation Agreement will provide guidelines, delimit areas of responsibility, and facilitate the successful transition of students from the HutchCC Honors Program to WSU, and ensure that students completing courses in the Honors Program at HutchCC will be able to transfer those courses without loss of credit or recognition to the WSU Cohen Honors College.

#### Agreement

- HutchCC Honors Program students with a cumulative grade point average of 3.5 or higher qualify for admission to the WSU Cohen Honors College and will be accepted upon submission of a complete application to the Cohen Honors College.
- HutchCC Honors courses completed with a grade of B or better will be granted credit for up to six (6) credit hours towards an Honors transcript designation or up to nine (9) credit hours for an Honors minor.
- HutchCC students transferring to WSU will be given the same consideration for Honors scholarships, grants, and awards given to other students who enter WSU's Honors College.
- Transfer students from HutchCC will receive the same Honors transcript or diploma distinction as other WSU students who complete Honors requirements by their graduation date.
- This agreement may be amended by mutual agreement in writing at any time.

This Agreement shall commence on May 2025, with the intent to admit the first students in August 2025, or as soon thereafter as administratively possible, and shall be reviewed after 5 years. This Agreement may be terminated at any time by the authorities of either Hutchinson Community College or Wichita State University upon sufficient notice to allow the completion to any given applicant cycle.
