

#### **NAUIGATING NAGPRA**

On January 12th, the Department of the Interior issued updates to the Native American Grave Protection and Repatriation Act or NAGPRA. The changes to the regulations are extensive including new, expanded requirements for consultation and consent for the exhibition of and research on artifacts covered by the law.

The law states:

"Requiring museums and federal agencies to obtain free, prior, and informed consent from lineal descendants, Tribes, or NHOs before allowing any exhibition of, access to, or research on human remains or cultural items.


"Eliminating the category "culturally unidentifiable human remains" and resetting the requirements for cultural affiliation to better align the regulations with congressional intent.

"Increasing transparency and reporting of holdings or collections and shedding light on collections currently unreported under the existing regulation

In order to be compliant with the new regulations, the museum will take the following measures:

- 1. We are currently taking an inventory of all of our Native American artifacts and establishing tribal affiliations or regions (as per new regulations). We will then send letters along with a list of artifacts to all tribal representatives asking permission to continue the preventative conservation of the objects and permission to research and exhibit items. If there is anything that needs to be returned or anything that requires special attention, we will ask them to identify the items and then we will proceed as necessary.
- 2. Until we get that permission, we will not display any Native American artifacts in any future exhibits.
- 3. Any Native American artifacts currently on display will be removed or exhibit cases covered.

This is an ongoing process and museums are still working to figure out how best to proceed and we are expecting it to be a lengthy process. Even though these new regulations will create many challenges we think it is important to be respectful of the laws and those in our indigenous communities.
