(1) Pathway to Stop Diabetes

American Diabetes Association (ADA) Due Date: Internal 5/15/2015; Application 7/1/2015

Pathway seeks exceptional nominees from a broad range of disciplines, including medicine, biology, chemistry, engineering, mathematics and physics. Pathway will support creative scientists early in their diabetes research careers, or investigators who are established in other disciplines but would like to expand their focus to diabetes research. Pathway will consider applications directed toward topics relevant to the prevention, treatment and cure of all diabetes types (type 1, type 2 and gestational), diabetes-related disease states (obesity, pre-diabetes, and other insulin resistant states) and diabetes complications. The Association encourages nomination of individuals from diverse backgrounds, including minorities that are underrepresented in research. **Institutions may nominate one investigator per grant cycle. The Collections in Support of Biological Research (CSBR) Program provides funds: 1) for improvements to secure, improve, and organize collections that are significant to the NSF BIO-funded research community; 2) to secure collections-related data for sustained, accurate, and efficient accessibility of the collection to the biological research community; and 3) to transfer collection ownership responsibilities. The CSBR program provides for enhancements that secure and improve existing collections, result in accessible digitized specimen-related data, and develop better methods for specimen curation and collection management. Requests should demonstrate a clear and urgent need to secure the collection, and the proposed activities should address that need. Biological collections supported include established living stock/culture collections, vouchered non-living natural history collections, and jointly-curated ancillary collections such as preserved tissues and DNA libraries. - Consider issues, challenges and opportunities facing U.S. advanced manufacturing, and source novel and unanticipated perspectives on technology priorities that can inform both the broad advanced manufacturing community and agency work.
- Provide a resource for rapid response expert advice to help inform cross-cutting federal research and development initiatives in advanced manufacturing. It is anticipated that these responses might be provided within from several days for simple informational items to several months for more complex issues.
- Serve as an intermediary for the Administration in soliciting the input of the broader manufacturing community and supply chains on technology strategies.

The Humanities in the Public Square program supports scholarly forums, public discussions, and educational resources related to the themes of a new NEH initiative, The Common Good: The Humanities in the Public Square. Designed to demonstrate the vital role that humanities ideas can play in our civic life, the Humanities in the Public Square program invites projects that draw on humanities scholarship to engage the public in understanding some of today's most challenging issues and pressing concerns. The Humanities in the Public Square program, a key part of the Common Good initiative, welcomes projects addressing a significant humanities theme that is important to a particular community, region, or state. The theme may be based on one of the questions above or it may address another significant public issue that is informed by the humanities in ways that will appeal to public audiences and concerns. The project should consist of 1. a public forum that engages scholars and humanities practitioners in discussion with a public audience about a theme; 2. subsequent public programs that would use creative formats to engage audiences in reflection on and discussion of a humanities theme for an extended period of time; and 3. educational resources that disseminate materials for ongoing use by teachers, students, and/or lifelong learners. Applicants are strongly encouraged to forge partnerships with other institutions as appropriate (especially state humanities councils), to ensure that the scholarly, public programming, and educational elements are all well conceived and realized.

Common Heritage National Endowment for the Humanities (NEH) **Due Date: 6/25/2015**

America's cultural heritage is preserved not only in libraries, museums, archives, and other community organizations, but also in all of our homes, family histories, and life stories. The Common Heritage program aims to capture this vitally important part of our country's heritage and preserve it for future generations. Common Heritage will support both the digitization of cultural heritage materials and the organization of public programming at community events that explore these materials as a window on a community's history and culture. The Common Heritage program recognizes that members of the public—in partnership with libraries, museums, archives, and historical organizations—have much to contribute to the understanding of our cultural mosaic. Together, such institutions and the public can be effective partners in the appreciation and

stewardship of our common heritage. The program supports day-long events organized by community cultural institutions, which members of the public will be invited to attend. At these events experienced staff will digitize the community historical materials brought in by the public. Project staff will also record descriptive information—provided by community attendees—about the historical materials. Contributors will be given a free digital copy of their items to take home, along with the original materials. With the owner's permission, digital copies of these materials would be included in the institutions' collections. Historical photographs, artifacts, documents, family letters, art works, and audiovisual recordings are among the many items eligible for digitization and public commemoration. Projects must also present public programming that would expand knowledge of the community's history. Public programs could include lectures, panels, reading and discussion, special gallery tours, screening and discussion of relevant films, presentations by a historian, special initiatives for families and children, or comments by curators about items brought in by the public. These public programs should provide a framework for a deeper understanding of the community members' shared or divergent histories. The programs may take place before, during, and/or after the day of the digitization event. Applicants may but need not include in their proposals a topic around which the event and the public programming would be organized. Topics proposed for the public programming may also be proposed for the digitization event. The applicant institution must plan, promote, and organize the event and ensure that a wide range of historical materials can be digitized and also contextualized through public programming. Since the help of additional institutions and organizations in the community may be needed to accomplish this work, the applicant must take responsibility for enlisting appropriate organizations or institutions, such as local libraries and museums, to contribute to the project, as needed. NEH especially welcomes applications from small and medium-sized institutions that have not previously received NEH support.

These challenges include the need to find better ways to preserve materials of critical importance to the nation's cultural heritage—from fragile artifacts and manuscripts to analog recordings and digital assets subject to technological obsolescence—and to develop advanced modes of organizing, searching, discovering, and using such materials. This program recognizes that finding solutions to complex problems often requires forming interdisciplinary project teams, bringing together participants with expertise in the humanities; in preservation; and in information, computer, and natural science. Secondary Analyses of Data on Early Care and Education

U.S. Department of Health and Human Services - Administration for Children & Families (ACF) **Due Date: Letters of Intent 6/1/2015; Applications 6/29/2015**

Analyzing existing data sets provides researchers an efficient and cost-effective method for answering critical research questions. Grants for Secondary Analyses of Data on Child Care and early Education will provide funding to address key questions that will inform both policymakers and future research. Existing data, which may have been collected for other purposes, have the potential to answer questions relevant to the goals and outcomes of the programs administered through the Administration for Children and Families, and in particular the Child Care and Development Fund (CCDF). Data of various types from a number of sources may be mined for these purposes. Topics of particular interest for these grants are: (1) measurement of quality; (2) subsidy policies and parents' access to high quality early care and education for their children; (3) qualifications, certification and credentialing of child care teachers and caregivers and its relationship to quality care and interactions between caregivers/teachers and children in support of children's development especially for those working with infants and toddlers; (4) interplay between family and child characteristics, employment status, and choices of care; (5) child care characteristics and child and family outcomes; (6) implementation assessment (or process evaluation) of programs/initiatives; (7) effectiveness of state systems in monitoring and maintaining standards of care, and relationship between qualification of monitors/inspectors and the effectiveness of monitoring systems; (8) cost-benefit/cost-effectiveness analyses of child care initiatives; (9) collaboration, coordination, and alignment of services among early care and education programs; (10) characteristics of early care and education programs (centerbased and home-based) and their relationship to indicators of program quality; and (11) characteristics of early care and education (ECE) programs (type of ECE, affordability, flexibility)
