EMPLOYERS GET A TAX BENEFIT FROM PAYING TOWARDS EMPLOYEES' STUDENT LOANS

Employers looking to entice prospective applicants or incentivize current employees to stay longer have a new option as of March 27th, 2020, provided by the Coronavirus Aid, Relief, and Economic Security Act (CARES Act), Section 2206. It allows employers to pay up to a maximum of \$5,250 towards an employee's student loan balance in a year's time.

Prior to the CARES Act provision, employers could make contributions to their employees' student loans, but the payment was subject to payroll taxes and the employee had to report it as income. The provision changes this, so that now, employers will receive the benefit of a tax exclusion as long as it is provided as part of an employer's education assistance program. For employees, the benefit of having their student loan debt reduced is the most obvious perk, but the payment is exempt from income reporting. Another bonus is that the employer does not have to provide the payment directly to the loan originator; it can be paid directly to the employee.

Another great thing is that it's irrelevant whether the debt was incurred while person was employed by the company making the payments; employers can pay on debt previously incurred.

As with any federally-provisioned act, there are caveats and exclusions. For one, the employer must establish a written plan and communicate the terms of that plan to eligible employees. This plan cannot discriminate in favor of Highly Compensated Employees (HCE's), or those whose compensation was above \$130,000 in 2020. Also, there regulations under Chapter 4 of IRS Publication 970 as to what will be determined as a Qualified Education Loan, but in general, the loans incurred must be for tuition and costs of attendance in pursuit of a "recognized educational credential."

Employers like the benefit not only for the tax exclusion, but for the opportunity to offer a competitive edge when competing for employees in a thin talent market. Employees can also use the provision as a negotiation tool when vying for promotions or salary increases. However, a person who is close to receiving student loan forgiveness may not see much benefit.

Originally slated to expire in December 2021, this benefit has been extended effective through 2025.

More Good News

Interest payments on federally funded student loans are suspended until **September 30, 2021.**

You do not need to take any action to receive this benefit.

UNIVERSITIES CREATE A PLAN TO EMERGE FROM THE PANDEMIC WORLD, ENTICE ENROLLMENT

There is no question - enrollment is down, and universities are having to be innovative in their approach to bringing in more students and offering options that will fit a variety of needs and preferences.

What Will Change

There will be a myriad of additional options in online classes and hybrid classes. Many universities have developed several more fully-online Bachelors and Masters degree programs that require no time spent in class at all.

Tuition

If you thought universities might lower their tuition rates to gain the interest of more students, think again. Most universities are keeping tuition level, and many are actually raising it. However, many are either reducing or entirely waiving the fee for online classes. For instance, Wichita State University made the decision to eliminate the online fee of \$97.25 per credit hour for the 21-22 academic year. This will level the costs between traditional and online classroom settings and offer more options for students to plan classes around life and work schedules.

Masks and Vaccinations

Many states have lifted their mask mandates by now. Kansas lifted its State of Emergency status as of June 15, 2021, and now many universities in Kansas, while they strongly encourage masks, will not require them inside classrooms or on campus.

Vaccination for COVID-19 are strongly recommended at many universities for both faculty and students, and several offer vaccinations on campus at no charge. However, there are many universities across the nation that are requiring all faculty, staff and students to be vaccinated in order to have campus presence. The <u>Chronicle of Higher Education</u> identified in an <u>article</u> 570 public and private universities as of July 1st that will require vaccination in some form.

Change for the Positive

Despite the struggles of the past year, COVID-19 has pushed forward many initiatives that have been in slow development in higher education to give students more flexibility in the ability to tailor their college experience to their needs. It's a welcome change.

Tutoring stipend from VA

Veterans enrolled half-time or more can receive a \$100/month and \$1200 maximum benefit to cover costs of tutoring.

The classes for which you receive tutoring must be part of your educational program, and your instructor must write a recommendation for your tutoring and submit it to your school's VCO.
