WICHITA STATE UNIVERSITY CHARTER BUS SERVICES STANDARD TERMS AND CONDITIONS

The Wichita State University (WSU) Charter Bus Services Standard Terms and Conditions identified herein ("WSU Terms") shall govern Provider's provision of Charter Bus Services ("Services"). To the extent that these WSU Terms conflict with any terms or conditions governing Provider's provision of Services, it is expressly agreed that the terms of each and every provision in these WSU Terms shall prevail and control over the terms of any other conflicting provision in any other document relating to the provision of these Services. The WSU Terms herein may NOT be altered, supplemented, or amended by the use of any additional document(s). WSU is purchasing these Services on the basis of Provider's acceptance of these WSU Terms.

Provider warrants as follows:

- 1. That Provider will provide a trained, licensed, and fully insured professional driver to carry out the Services. Provider shall maintain a record of each driver's CDL number and be able to show proof that each driver is properly licensed.
- 2. That Provider shall comply with all Federal, State, and Local laws, regulations, and ordinances governing the Services.
- 3. That all buses and equipment necessary to fulfill the Services are in good working order with no safety defects at the time of departure and conform to proper standards of industry.
- 4. That in the event of mechanical breakdown, or accident, Provider shall be responsible to timely provide substitute buses or to subcontract with another approved provider, if necessary, to complete its obligation.
- 5. That Provider maintains insurance in the following amounts:
 - a. Comprehensive General Liability Insurance with bodily injury and property damage limits of not less than \$1,000,000 per occurrence.
 - Automobile Liability Insurance of not less than \$1,000,000 per occurrence for common carrier to provide in-state transportation services or \$5,000,000 per occurrence for Interstate Commerce Commission (ICC) carrier to provide out of state transportation.
 - c. Workers' Compensation in amounts as required by Kansas law.
- 6. All liability insurance policies will name WSU as additional insured with respect to claims, demands, suits, judgments, costs, charges, and expenses arising out of, or in connection with, any loss, damage, or injury resulting from the negligence or other fault of Provider, its agents, representatives, and employees. Provider must furnish certificates of insurance to WSU in the limits set forth above following minimum limits prior to execution of an agreement.
- 7. Under no circumstances shall WSU'S use of Provider to perform the Services be construed or interpreted as an

exclusive dealing agreement. WSU is free at any time to contract for similar services with any other party, or to perform such Services itself.

- 8. Neither WSU nor Provider shall be deemed to be in default of any term of these WSU Terms or liable for failures in performance resulting from acts or events beyond the reasonable control of such party. Such acts shall include, but not be limited to, acts of God, civil or military authority, civil disturbance, war, strikes, fires, other catastrophes, or other events beyond a party's reasonable control.
- 9. Provider shall indemnify and hold harmless WSU against any and all loss or damage to the extent arising out of Provider's performance of Services or in any way incidental to or arising out of the occupancy, use, service, operations or performance of work hereunder.
- 10. WSU shall not be precluded from receiving the benefits of any policy coverage or proceeds that an insurance company may carry which provides for indemnification for any loss or damage to property in Provider's custody and control, where such loss or destruction is to WSU property. Provider shall do nothing to prejudice WSU's right(s) to recover against third parties for any loss, destruction or damage to WSU property.
- 11. No provision of this Agreement will be given effect that attempts to require WSU to defend, hold harmless, or indemnify Provider or any contractor or third party for any acts or omissions. The liability of WSU is defined under the Kansas Tort Claims Act (K.S.A. 75-6101 et seq.).
- 12. In accordance with Kansas Executive Order 18-04, Wichita State University has policies prohibiting sexual harassment, discrimination, and retaliation.
