## Prices:

Discounts shall remain firm for the duration of the contract. All contract prices shall be fixed to a January price list. Any contract price increases shall be update ed each January.

In the event a net discounted price falls below Fisher's cost, Fisher is permitted to charge the Kansas Board of Regent participating member institution a price equal to Fisher's cost plus 15%.

## Shipping:

Freight terms for Catalog Products shipped from Customer's assigned Fisher warehouse are F.O.B. Customer's U.S. destination, normal freight prepaid and absorbed by Fisher. Fisher shall waive all freight related charges such as regular ground shipping, dry ice, hazardous materials, integrity packing, etc. The only freight related charges Customer shall pay for deliveries of Catalog Products are rush charges. For orders of Non-Catalog Products (also known as third party products), terms shall be F.O.B. shipping point, freight prepaid and charged to Customer at Fisher's standard freight rates.

Requests for special handling, air, or other requests will be prepaid and added to the invoice.
